3. A sentence stating that you (or your school or district) will be fully responsible for all transportation and incidental costs and will refund the scholarship if you fail to attend.
4. A short description of the course, unit, activities, etc. in which you teach personal finance or your specific plan to introduce it.

Please, no phone calls. Jump\$start will administer the requests on behalf of Experian.

### **Criteria**

Applicants must be:

- Full-time, licensed/certified, PreK-12 teachers, currently employed by a school or school district.
- First-time attendees of the Jump\$start National Educator Conference.
- Teaching personal finance (as a course or integrated into other subject matter) currently or must have a specific plan to introduce it.

Priority will be given to teachers from areas under-represented in conference registration as of October 3.

**Apply right away!** Deadline to apply is September 25. Scholarships will be awarded on a first-come, first-served basis, subject to the criteria and priorities shown above.

### **Code.org Adds Free App Builder for Kids, Teacher Training**

Seattle-based Code.org is expanding way beyond online programming tutorials for students.

The nonprofit announced a computer-science education platform called [Code Studio](#). It includes an online learning tool that students can use to create apps and send simple apps to phones.

Also announced are in-person, professional development workshops for teachers wanting to use Code Studio in their classrooms. Code.org taught 700 teachers this summer and hopes to reach 10,000 more this year, according to Code.org co-founder Hadi Partovi, a former Microsoft manager turned startup investor. Workshops are planned in [more than 60 cities](#).

Code Studio also includes computer-science curriculum that is being used in thousands of classrooms and the ["Hour of Code" tutorial that last year introduced more than 10 million students](#) to computer science.

All the offerings are free and supported by donations that Code.org has received from leading tech companies and industry leaders.

### **Fall 2014 Edition of the Montana High School Business Challenge**

The key to getting your students to understand key business concepts is through hands-on activity. If you've not yet done so, consider this simulation designed to develop management, financial, marketing and critical thinking skills in a competitive, learning enhanced environment.

The Montana High School Business Challenge, sponsored by the Montana Chamber Foundation and administered by the Montana Council on Economic Education lets your students actively participate in a state-wide simulation as real entrepreneurs. The students manage the business of a Digital Music Player

manufacturer, and many daily decisions face the students, including financial, ethical, legal, and competitive issues. It is a dynamic simulation that can be incorporated into many different class disciplines.

The state-wide competition runs eight weeks, beginning Wednesday, October 8 and concluding Wednesday, December 10. College scholarships are awarded to the top three teams. The cost is \$15.00 per team.
