

### **Fun Facts for April Fools' Day**

While the exact history behind April Fools' Day is unclear, there is one widely believed theory for how April 1 became an annual day of trickery. According to [Discovery.com](http://Discovery.com), the holiday stems from people who refused to adopt the Gregorian calendar in favor of the older Julian calendar when it was established in the 16th century Europe. While most adjusted to the new calendar, which moved the New Year from April 1 to Jan. 1, those who refused to recognize the change were reportedly subjected to pranks and ridicule and were rumored to have been called "April Fools" for observing the holiday months later.

America is not the only country to celebrate every April 1. While France, England and Canada also join in on the sneaky festivities, [other countries](#) take the annual holiday more seriously. According to one report, April Fools' lasts for two days in Scotland, with the second day focused on children pulling pranks "involving the backside."

While Americans know April 1 as April Fools' Day, other locations celebrate the day under a different moniker. In France, where the day of pranks is rumored to have originated, the pranking day is referred to as "Poisson d'Avril" (April Fish), occurring to a report from [CNN](http://CNN). Scotland's participants reportedly call the holiday "[Hunt-the-Gowk](#)" ([Cuckoo](#)) Day and the following day, "Taily Day." The ancient Roman version of April Fools' was [Hilaria](#). Meanwhile, Hindus celebrate the arrival of spring with the color festival of Holi.

## **Perkins 'Intent to Apply' AND State CTE/VoEd Application NOW OPEN – Due April 24**

The Office of Public Instruction has again this year combined both the Federal Carl D. Perkins 'Intent to Apply' AND the State CTE/VoEd Funding application for school districts' convenience. You can apply for one or both funding programs using this one electronic form.

*Please note: this is an application Authorized Representatives (AR) complete, not teachers. ARs are typically the district superintendent or someone given authority by the district regarding money.*

The online link to access and complete the combined Federal and State funding application is now available and listed below. It is also available on the Secondary CTE web page of the OPI website inside the *Perkins Federal Funding* tab.

Authorized Representatives of Local Education Agencies (LEAs) will use the online link to access and complete the brief electronic application for the 2015-2016 E-Grants cycle.

All public high schools and K-12 districts with qualifying Career and Technical Education (CTE) programs are eligible to apply for funding. Elementary districts are not eligible for Perkins or State CTE/VoEd monies.

**Districts will NOT receive a 2015-2016 Perkins allocation unless this electronic form is completed and submitted online** at the OPI on or before the deadline. These designations are binding and cannot be changed once allocations have been downloaded into the E-Grants system.

## **2015 MIET Tech Days Registration is Now Open**

The [2015 Montana Institute on Educational Technology](#) (MIET) Tech Days will again be offered this June for the 11th year in a row on the Great Falls College Montana State University campus Tuesday, June 23 and Wednesday, June 24.

Although continuing the tradition, the conference does have some important changes which should be beneficial for everyone.

Changes and highlights for 2015 include

1. MIET will now be a concentrated two-day conference. There will be over 50 session options from which to choose along with two keynote speakers.
2. Classes will be open enrollment, similar to MEA, and will be on a first-come, first-serve in rooms with a cap at 30 attendees per session

3. An Open Session will be offered—if you missed a session or an offering you needed was not offered, the last sessions on Wednesday will provide it. The talented instructors will survey attendee needs and then offer what you asked for!
4. BYOD—Bring Your Own Device so you have the opportunity to have more practical, hands-on learning with your own device and access will not be limited to 18 computers per lab.
5. College credit of your choice will be offered for an additional fee—one (1) or two (2) masters-level continuing education credits. Participants must attend both full days to be able to earn college credit. The one-credit course includes full attendance and a reflection assignment or project. The two-credit course includes full attendance, a two-hour evening session, a 13-hour online course after MIET, and a reflective paper.
6. Lunch is included both days.

## **Today is Deadline to Respond to Proposed "Programming for Teachers" Course at UofM Next Fall**

The University of Montana in Missoula is proposing a course for fall 2015 titled "Programming for Teachers."

The instructor for the course will be Michael Cassens with instruction being held online with web-based face-to-face times to be determined.

The course will be offered for three (3) credits through Continuing Education. The total cost for the credits has yet to be determined.

The course will focus on either [Python](#) or [Java](#); whichever is the consensus. The goal of the course is to teach the language and pedagogy for teaching programming. Programming education in Montana is expanding. The number of students requesting a programming course or considering a computer science direction at the university level is increasing. At the moment there is no course in Montana to teach teachers programming and this course is an attempt to fill that need.

"Programming for Teachers" is intended for anyone interested in teaching programming. Prior knowledge of some programming language would be useful but considering the lack of experience in the state beginners can be accommodated. There should be more than enough experienced programming teachers enrolled to help those totally new to the subject.

Since this is a first-time offering the first-time takers will be involved in writing the course. If you have particular things you would like to see in the course be sure to suggest them to either Garth Flint

### **CTE Spring Data Collection For Perkins Funding Now Open – Time to Identify Concentrators**

The Career and Technical Education (CTE) Spring Data Collection began March 1, 2015 and ends April 30, 2015. This AIM collection asks schools to identify all 12th grade high school students who were enrolled at any point during the current 2014-2015 school year who meet the definition of a CTE Concentrator.

CTE Concentrators are 12th graders who have earned three (3) or more credits in any CTE program in any combination during their years of high school. Currently enrolled CTE courses count toward credits earned.

CTE Concentrators must have the '*CTE Concentrator*' box checked and an '*Area of Concentration*' entered into the AIM/Infinite Campus data system. If the student has a child or shares the parenting of a child, the '*Single Parent*' box should also be marked.

High schools who receive funding from the Carl D. Perkins federal grant program must complete this CTE Spring Data Collection.

### CTE Student Participation Reports – Now Collected from TEAMS

The 2014-2015 Career and Technical Education (CTE) Student Participation Report information used for CTE program approval and CTE State funding allocations will be extracted from the TEAMS (*Terms of Employment, Accreditation, and Master Schedule*) information already submitted and on file at the OPI. This change means that CTE teachers and/or other district personnel will NOT be submitting participation report information via an online link as they have in the past. Good news!

Because the CTE tab in the TEAMS data system had not been activated prior to the November deadline, **a few items on the new CTE tab will require each districts' attention now**. The CTE tab has just been made available and is ready for input from high school districts.

The items needed are: CTE programs offered, CTE teachers with an extended contract, and identifying the number of males enrolled in each CTE course (only enrollment totals were reported). Next fall, all CTE information will be added at the same time as the rest of the TEAMS fall data input.

To add the additional CTE information into TEAMS, a password is required to log in. Authorized Representatives (AR's) will either ask those personnel in their district who already have access to TEAMS to add the additional CTE information, or they will assign someone new to add it. For any new TEAMS users, AR's must submit a signed *TEAMS Security Form* to the OPI requesting School Level access for those new TEAMS users.

Once access is granted, follow the instructions found at [http://www.opi.mt.gov/pdf/SchoolStaffing/15CTE\\_Help\\_Guide.pdf](http://www.opi.mt.gov/pdf/SchoolStaffing/15CTE_Help_Guide.pdf) to find and fill out the CTE screen in TEAMS. The link to the TEAMS login is shown below and also posted on the OPI website under the 'Reports & Data' tab on the 'School Staffing Project/TEAMS' page, as a purple button labeled, 'TEAMS Login'.

The CTE information collected in TEAMS is used for Carl Perkins accountability reporting and factors that determine the State CTE (State VoEd) allocations. Therefore, it is imperative that the information submitted is complete and accurate. Any high school district planning to apply for Carl Perkins and/or State CTE (State

VoEd) funding for next year (2015-2016) should submit the additional data in TEAMS for all current CTE programs at their high school.
